Treasurer's report

- Report was handed out with an opening balance of \$5,361.22.
- Revenue for the month was \$379.75.
- Expenses were \$1,467.08.
- Operating balance of \$3,273.89, plus the prudent reserve of \$2,167.24, total: \$5,441.13.
- Last month Foster had asked CSRs to check with their groups to see if the 6 month report reflected all of the group contributions. No feedback reported from the groups.
- Foster is available to members to discuss the role of treasurer for September's elections.

- Financial reports on the website Mike C contacted intergroup in Ottawa, and found out they do
 not post financial documents online. He checked with Toronto, and found that they post general
 numbers in their minutes. Foster suggested that we keep the level of financial information in our
 minutes, which are published online. Status quo will be maintained.
- Email monitoring An anonymity or confidentiality issue was raised a couple of months ago at CS, whereby CS decided that too many people had access to the help@aahalifax.org email address. Since then, however, the issue was raised that email answering is the only position that is not accountable to CS in some way. If the email coordinator was absent or went back out, without someone else having access, it could be a couple of months before anyone knows. Also, it was suggested that

there could be some content oversight to ensure no wild responses were being given out. When something on the website or in the newsletter goes off the mark, for instance, CS hears about it.

- The current Email Coordinator recommended that the Email Coordinator emails the CS Chair with responses to individual emails, deleting personal information, with the Webmaster being the backup for email account access.
