My on-going saga of trying to find a good home for the French text Big Books continues as I still have not found any takers. I believe where I left-off at the last meeting in August, I had contacted Cape Breton Area groups with no interest. As well, I was in Fredericton last week and I attended a meeting while I was there.  - **VII. Entertainment Co-chair** there wasn't 3 calls for nominations, but the CSRs are asked to take it back to the group to see if there is any interest in the position.

New Business:

a) 2017 Mid-Winter Round-up – Decision - Paul and Jim, Co-chair of MWRU – There was a lot of discussion around this topic, so this is a synopsis of that discussion. In a nutshell, the Holiday Inn is not available due to renovations. The committee had an agreement with the Westin, which was for \$6000 plus sales tax. The Westin was the only hotel to fit the bill, so to speak, as per our other round-ups at the Holiday Inn, numbers of attendance, etc.

They had voted, as a committee, to have the round-up and take the loss. But when Tim, the Chair, called again to try to work out a better deal, the Westin informed him that they have forgotten to put on the 17 percent Administration fee on to the agreement, which put the bill over \$8000. Also, parking being an issue as well. With the new information, at the last meeting, the committee voted to cancel the round-up for this up-coming year. The MWRU committee was coming to Central Service with the following Resolution:

2017 Mid-Winter Round-up Resolution

As the 2017 Round-up could not take place at the Dartmouth Holiday Inn due to renovations: the Committee canvassed the Halifax Regional Municipality for a new venue for February; the only facility meeting all the requirements for the Round-up was the Westin Hotel, who submitted a proposal after negotiations with committee representatives.

The over-all budget for the Round-up was developed taking into account significant higher costs for the facilities. The forecast projected a serious deficit requiring coverage by the Central Service Committee.

In consultation with the Executive members of the Central Service Committee, it was determined that the probable deficit was beyond the means of the Central Service Committee.

Therefore, be it resolved that the 2017 Mid-Winter Round-Up be cancelled.

As Central Service only votes on motions, Jim made a motion that "We, the Central Service Committee, due to financial restraints, cancel the 2017 Mid-Winter Round-up." Allan seconded the motion. A lot of discussion followed this motion.

What came out of the discussion was that the committee has used only the requirement from previous round-ups, that there hadn't been much discussion on reducing numbers and the make-up of the round-up, programs, how many days needed, etc. Many people believed that even if it was only a one or two day event and if the numbers were reduced, that more venues would be available. The change would be just for this upcoming year and the next committee could look at returning to the previous set-up, if financially feasible. Many ideas were floated, but it would be up to the MWRU as to how to proceed. A call to vote on the previous motion was made. A vote was taken – For – 6, Opposed – 13, Abstaining – 3. Minority voice was called, no additional information was presented. No votes were changed. The 2017 Mid-Winter Round-up has not been cancelled. We have asked the committee to get back together before our next meeting in November and bring us more information on what they plan to do.

There weren't any missed announcements this month.
