

We have 593 subscribed members getting the monthly email, like previous month. This past month I installed and activated some extra security functionality in WordPress. We are now better protected as indicated by these stats: Total number of IP Geo-blocked: 367 (number of unique locations attempting to access our site) IN, India (44). PH, Philippines (26). PK, Pakistan (15). MY, Malaysia (14). GB (9). SE (7). IT (7). NL (7). LK (6). RU (5) Access areas: Admin login (221) and non-pages (18)



The above shows that we have quite significant and continuous attempts to break into our WordPress site. Some are login attempts, possibly using brute force method. And other are attempting to exploit known SW vulnerabilities. For these the best protection is to keep the site up-to-date with the latest SW. We also had a quick meeting after to discuss the appointing a new Co Chair. The presentation with the Guidance Counsellors was well received by both The School Board and the Counsellors themselves. Thanks to the Chair of PI and the committee It was a pleasure to have worked with the PI Committee on this project! There will be a meeting with Success College this Thursday.

<u>Public Information:</u> Presentation was made to the HRSB with PI/CPC participation. It was held in an auditorium with different tables set up. Every 15 minutes a different group of Guidance councillors were at our tables. We collected email addresses, distributed pamphlets, meeting lists, referred some to Al-Anon and so forth. We had face to face discussions on various levels of alcoholism, some personal, and even a mini 12 step discussion going on in a corner for some of the councillors directly affected by alcoholism. It was uplifting for all of us involved. We felt we had certainly carried the message and that meeting, and our discussions will produce results in us receiving requests for presentations across the HRM at all levels of schools from elementary to high school. **Question**: How many Guidance Councillors attended this event? **Answer**: at least 40, maybe even more. We had people at our table all day.

Treatment: I am forwarded you our report, I apologize for being absent for the Central Service meeting, however when I signed up for this position it was on Sundays and not Tues evening.... I have and had prior commitments on Tues eve, I had hoped moving forward that I would be able to participate but it seems my Tues eve prior commitments have been ongoing and will be for some time. My co- chair is available sometimes; however, it has been challenging for him on Tues nights as well. This past month the Detox meetings have been going well with group's participation and all meetings scheduled members have maintained their commitments. I appreciate the on – going support and recognizing the support required when individuals are trying to get sober, while maintaining your own sobriety through recovery unity and service. This past month the Forensic meetings have not been going well. Many Team members are moving onto other service positions and it seems the word is not being spread by all groups of the necessity of having meetings here once per week. I encourage all groups GSR's to try and get their group members to step up and try service work in Treatment – Forensics. Average attendance is about 5. I am still looking for new members of the fellowship to step up and join the forensic teams. Wishing you all the best over the holidays and in the new year.

<u>Corrections:</u> Meetings were well attended at the prison. The Chairs reported that sharing was meaningful. A meeting had to be cancelled once due to a lockdown. We are still looking for men to chair meetings in the prison. A criminal records check is required, but no particular length of sobriety is needed. An order for literature went in this month. We will be having a committee meeting in Jan. Wishing everyone a Merry Christmas and a Happy New Year.

<u>District 1</u>: It has been a quiet month, with many new things coming in the New Year. District 1 will be having a Pre-Conference in the New Year. Will a full day of discussions on the agenda items from New York. I've spoken to many members about our Pre-Conference and seems like we'll have a lot of input. Which is exactly the whole point of having our conscience heard at the Conference. Our NYD was very excited to hear that here in District 1, we wanted to be a part of the greater whole. The date for the Pre-conference will be picked in the New Year. We have passed our new Guidelines and will be posted on our website shortly. The old guidelines will stay up for review, but are not valid as soon as the new are posted. I would like to know if you wanted to have a potluck this month for the Holiday, all are welcome.
