#### Literature:

Good evening, A deposit of \$1,375.70 was made Feb. 27, 2018, which brings the balance of the literature account to \$2,198.83. A total of \$535.65 in orders has been removed from inventory before the Round up and a total of \$840.05 was sold at the Round up. We did a book draw every hour on Saturday to remove 11 75th Edition reprint of the 1st Edition Big Books (11 x 17.00 = \$187.00) that have been in the Inventory for over a year. We had a lot of fun with it and made a total of \$270.00 (\$83.00 extra)! A big Thank You to Gerry L., Rob A. and Tim M. who helped me man the table all weekend and bringing the boxes to and from the room each day. There is 1 order I am delivering this evening for Corrections totalling \$290.00.Inventory balance when I took

over for Sheila was \$6,394.00. It is currently \$5,018.30. I will be making an order for GSO in the next few weeks. Under the direction and guidance of Bill P. and Bruce B. I set up a Scotiabank Visa debit account with \$1,000 deposited from the Literature account in it to order Literature. Past Chairs have used their personal credit cards to order literature from GSO. I do not believe anyone should use personal funds for AA business, so we set up the Visa Debit account because it has the lowest per month fee of \$3.95 for 12 transactions a month, plus no interest charged for the use of the card, unlike a prepaid credit card. We only order literature maybe once every 2 months, so this is more than sufficient. The Treasurer has access to view this account online. I took possession of the Literature from Sheila on Feb 10th and the insurance has been transferred over to my home address. The Insurance person we deal with said he will send out new policies that reflect this change. I have to thank the cochair Paul B., Al Mac., Rob A. and Gerry L. for helping me load and unload the boxes. Sheila also turned over a float of \$230.00 which I used over the Round up weekend. I have kept that cash as a float for making change for cash orders. It is in the Literature cash can under lock and key. As things go, I am getting to know my way around the Literature stock, and I have called Sheila with a few odds and sods questions that she has been more than happy to answer. I have sent the webmaster the new order form with my contact information on it. Please pass along my information to the person responsible for literature at your groups. #### **Insurance Policy:**

Paul B was speaking with our insurance contact Harlan Hayes while setting things up for the literature committee and he asked if all the AA groups currently listed on the insurance policy was correct.

Answer: Yes.

Question: Leah asked if the distribution breakdown was marked in the 2018 budget.

Answer: Yes, there are standard yearly donations, but because we have a surplus these numbers may change.

# **Detox performance:**

Mike H suggested that a meeting of the executive committee do a cause analysis as to why detox performance has been down, And that this be tabled for discussion at the next meeting.

**Question:** Paul asked if a clarification be made of the phrase "detox performance" - did something happen? Should this be brought back to our groups?

Answer: Things have not been happening, we wish to discuss ways to tighten the holes so things can work properly.

Comment: Rob mentioned that he located the problem with the website detox schedule listing and that has all been realigned and fixed

Question: Emily noticed in the treatment report that the chair was having difficulty with the contacts for the groups and

communication. Maybe this is something that could be discussed.

**Question:** Trudy noticed that Tina said in her report that the problems have been fixed so she wondered what would be discussed in a meeting about detox. She agreed that groups needed to update their contact information with Tina.

Question: Freddy asked if Tina attended Central Service meetings.

Answer: No.

Question: Kent asked if this executive group would be obtaining information which would be brought back to the Central

Service table for discussion.

Answer: Yes.

**Question:** Samaira pointed out that it was known that Tina was unable to attend CSC meetings when the groups were switched over from District meetings. She has never heard of the executive to deal with an issue on its own - anything that needs to be discussed should be discussed at the table. She saw that Tina had identified and addressed both problems already.

Chair: So that has been put to rest.

#### Reimbursement on security checks:

Kelly D stated that she explained to the applicant who was rejected that he would only be reimbursed if his application was successful. He still demanded his \$30.

**Comment:** The chair reiterated that there was a firm resolution on the table that the only people reimbursed would be people who passed their security checks.

**Question:** Paul asked if the individual was told in advance. Samaira suggested that the non-reimbursement policy be noted In our quidelines or on the form for volunteers to see before they apply.

Answer: Yes. And all applicants are sent a detailed email with this information before they apply.

**Comment:** Alan suggested that since everything had been explained to the individual, we should stay with the status quo. **Question:** Ron H asked what is the spirit of this rule that we not reimburse those who are not successful in their application? Was the rule made to limit the number of people who would try to help out? Did something happen? What is the history behind this? Here is someone who is genuinely trying to help.

**Comment:** Trudy said she has heard around the table many people ask for details about applying and we have said at this table is it up to the discretion of the institution - and we encourage people to apply and try their luck, but then we are saying we won't give them their money back unless it turns out a certain way. She doesn't think it is fair that the institution decides on the application but we make the decision about the money.

**Comment:** Rod stated that if he knew the institution would be suspicious of him due to his past, he would not choose to apply. **Question:** Paul asked if the resolution on the topic was passed at District level, would it have a bearing on anything at the Central Service table?

Answer: (Bill) You are absolutely right; Central Service has no policy on the security check.

Ron H made a motion that applicants for security checks at corrections be reimbursed regardless of the outcome.

Vote: All those in favour: 19 Those opposed: 0 Abstentions: 1. Motion carried.

**Question:** Samaira asked if the Central Service guidelines include the four new committees. The reason we started writing guidelines is because we needed guidelines for the four committees specifically - the detox facility asked for certain rules in particular. This broadened into having guidelines for District in general. Can we just say this central servece table doesn't follow them? Have these been added to your Central Service guidelines?

Answer: The quick answer is no. We will table this for the next meeting so that it comes under old business.

## **Announcements from Groups:**

Donnie announced that the last Thursday of the month the West End Step Group will not be holding a meeting due to a church function. Rob announced that the Welcome Group and the Downtown Halifax groups have changed their meeting times from 8 pm to 7 pm. Trudy gave a reminder that she has forms for GSRs who are interested in attending the Truro service convention. Samaira announced that the first pre-conference will take place April 7, everyone is welcome.
