Corrections:

While there is a stable base of approved members to attend meetings, there is a requirement for additional (men and women) members to become involved in the CNSCF weekly meetings. Nancy D will be looking after literature at "the store" on July 6 for us. Hours are 11-1 that Saturday. We will also be open on August 10.

There is a current price reduction from \$15.99US to \$9.99US (\$14.00CDN) for the MP3 Audio Download of the book Language of the Heart (Bill W's Grapevine Writing's). Go online to the Grapevine website.

Note: You will notice a difference between my report and the treasurer's - this is due to an outstanding check which has now been deposited. The biggest change this month was the purchase of a lot of pamphlets - we were very low. Every item has now been inventoried and labeled. We reorganized the purchasing list by code which I find much easier to work with.

Q: Why is the central service committee paying for the literature committee to attend area functions and roundups? A: It states in the guidelines that the literature committee will attend functions where invited or requested. This was not done previously, until last year. These venues can't afford our travel expenses (similar to the archives when requested to attend events). Central Service does not absorb this cost; the literature committee absorbs this cost. Q: But you don't make a profit. A: The effect is that the inventory is slightly reduced.

Comment: Other districts don't have a literature committee and this is a need we can fill and a service we can offer to be of help. Many other districts like Yarmouth or Cape Breton have purchased their literature from District 1&2.

Q: Is there a change that needs to be made to the budget to address this issue? A: In the past, travel for the literature chair has been covered as a personal expense. Yes, we need to look at adjusting the budget to cover this cost in the future.

CS Chair: Early this year I examined the literature committee and determined that it has always been running as an independent operation, offering a service. Any revenue received from mark ups on the books should go to expenses of operating the service and to allow for purchasing in advance of sales. Cathy has been working to determine if the current amount is sufficient to cover these costs.

Q: Was the earlier suggestion for the "fire sale" of old materials moved on? A: No, I have been focusing on other issues - the is idea is under consideration.

Bluenose Bulletin:

This month the Bulletin's theme is Diversity and Inclusiveness in AA. As we were taught from day one, keep an open mind and care for all suffering alcoholics.

Public Information: Good evening everyone, lots of things to report with our committee. As previously reported Northwood Nursing Home had asked us to put on a meeting the 3rd Wednesday of June, July and August from 2-3. I received an email last week asking us to continue for the month of September, October and November. Northwood also advised us that going forward when new residents are going through their intake, if they have any issues with alcohol they will be providing them with information about AA. We are continuing to work at getting our pamphlets into more nursing homes. We have been asked by Adsum House (shelter for women and children) to put on a presentation for the residents on July 15, 2019. This invitation came through asking them to take our pamphlets. Going forward we will be contacting other shelters and homes who we provide pamphlets to and see if they would be interested in a presentation. We had a list of several medical clinics and doctor's offices for the metro area and one of our members made calls to all the clinics that were not already assigned to a group. We now have over 30 more offices who would like to have our pamphlets. Please announce at your groups that we need help delivering pamphlets. I am very excited about attending the NS Service Weekend this week. I will have a booth set up all weekend and am looking forward to the Information Session for the 4 committees on Saturday evening. It was reported that although AA meetings at Detox are greatly appreciated some volunteers are making negative comments towards the success of AA as a whole, the viability of drugs used in order to help patients with their efforts to abstain from using and "God Bashing", which Detox asked members to refrain from doing. Given the importance of this life-saving experience, it would be appreciated if the CSR's would take back to their groups that we are there to spread the message of AA in a positive manner focusing on the importance of willingness and open mindedness in attending AA meetings once they have completed the Detox program.

Chair CS: It is difficult to discuss this without a representative from the Treatment committee present. This discussion will be tabled until next month.

NEW BUSINESS:

Six Month Treasurer's Report

- we have collected less than half the contributions for the year
- You will note transfers to Literature committee there was a mix up with a check made out to Central Service which should have gone to the literature committee you will see how it's cancelled out in the expenses
- There is a miscellaneous expense which was covering a literature expense Trudy paid out of pocket
- We're on schedule with the projected budget there are no surprises.

Q: How many committee chairs are being sent to the service weekend? Is there enough funds to cover the cost of the literature committee chair (\$180)? A: Yes. Q: Considering what was voted on about sending the incoming chair to Arizona for the intergroup conference, I think we should look carefully at the budget. Only 38% of group contributions have come in. I don't think we have enough funds. A: We have carried a financial surplus for approximately five years, this trip will create no financial hardship for the committee. Q: If it is in the guidelines that the literature committee is approved to attend other area events when requested, how is that in this year's budget? That has never been approved. A: Historically the literature committee has had an account independent of Central Service. This budget excludes anything to do with the literature committee. In the 2020 budget there will potentially be a line representing literature expenses, but currently these funds are not coming out of CS.

Motion put forward by Steve A of Back to Basics:

The Districts 1 & 2 Meeting List is now "updated every month by the Newsletter Committee" (minutes of May 7th, 2019, Central Service meeting, page 5); as a result, and on behalf of the Back to Basics Group, **I move** that the Meeting List include *the date of last revision* so that the Back to Basics Group can ascertain if, other than the name of the month, the actual content of the Meeting List has been changed.
