Why is this on the agenda when it has not been finalized? **Answer:** We go in with the hopes that we can move ahead on this, but of course if it is voted down we will stop discussion on it. The idea is trying to open up the provincial round up duties to more districts to more evenly carry the load.

NEW BUSINESS:

A motion was put forward by Eric L of the Four Seasons Group that all groups in District 1 & 2 be placed on the rotation for the weekend phones and the detox meetings. Seconded by Kelly D.

Currently there are 52 groups available to help out with these rotations and yet there are only 17 of the 52 who take the phones and only 20 of the 52 who help put on detox meetings. The groups who take it on are feeling it is a heavy commitment because they have to take on these duties so often because the rotation is so small. The idea is presumed consent - if the groups don't want to participate they will contact the chair of the relevant committee to let them know, but otherwise they will automatically be placed on the rotation list.

Comments:

- We can't force groups to volunteer. Each group is autonomous.
- From a DCM perspective, about half the groups are active in this kind of service but those who aren't active have good reasons. How many groups have CSRs and GSRs, let alone are able to participate in this kind of service? Some groups only have a handful of members.
- A more refined motion could be worded to encourage groups to try this, instead of presumed consent.
- It could be the responsibility of the committees to sell the idea to groups and raise awareness rather than force.
- Many groups do not know they are even eligible for this type of service; the message needs to be carried to them.
- With experience in other non-profit organizations, it is common that 10% of the volunteers do 90% of the work. AA is a unique organization and this type of motion could work against our unique traditions.
- If the decision is made for the groups, there is more of a chance they will not show up. Telling people what to do makes
 enemies.
- We could suggest that committees reach out directly to groups to raise awareness, answer questions and encourage them to participate; this could be done every two years, every time a new chair is elected.

VOTE: 5 in favour; 13 against. Motion defeated.

Announcements from Groups:

- There is plenty of brand new literature available: pamphlets on AA accessibility, the God Word, Many Paths to Spirituality and Mental Health. There are also new Grapevine Books: One Big Tent, AA for the Military and AA for Women.
- GSO has a quarterly newsletter which has very useful information.
- Bruce B is celebrating 9 years of sobriety on May 25.
