Chair:

CSC Chair Report October 1, 2019

- 1. It was an intense month. I attended the meeting of District 2 and submitted a report to Districts 1 and 2 on behalf of Central Service.
- 2. Committee meetings were slow in September with hurricanes and trips by Chairs.
- 3. There was a delegation of three members representing Central Service at the ICOAA Seminar in Arizona for 2019.
- 4. Mike and I attended with Marie Mac accompanying Mike. I paid for her registration. There were three workshops in each time slot which we were able to cover.
- 5. There were about three hundred people in attendance, the majority paid staff of Intergroup offices with a few volunteers. The Seminar was attended by the Chair of AA World Service and the Trustee and lead staff of the Grapevine.
- 6. Everything was recorded and I paid for a flash drive which was promised within a month.
- 7. I took vacation days before the Seminar with Mike and Marie after. We will get together when they return to develop a report of our mutual learnings from the event.
- 8. There is chat group of Intergroup and central service committees. It is secret and requires permission from the administrator to join. I will follow up on this in the next few days on behalf of chairs of Central Service.
- 9. Some quick highlights, we can join the GSO meeting list app quite easily. This will need to have a meeting list separated from our web site to synchronize with this app. However, the California groups use another app which links to Google maps and allows for specific directions. More on this after I get on the Intergroup site. In any case we can have some app running locally before the year end.
- 10. The literature is largely sold though the intergroup offices. This includes AA literature, non-AA literature (Hazelton) and what is called Drunk Junk medallions coins birthday cards pens etc. There is no formula for the mark ups other than

low on AA materials, higher on non-AA literature and scandalous on Drunk Junk. Literature is a profit centre for the Intergroup with offices.

- 11. There remains the range of Committees who set policy and have the last word but the coordination and design of implementation is dependent on office staff. Volunteers man the phones, their web sites, etc.
- 12. Because of American laws with staff and a retail store they are legally incorporated and have a federal charitable tax number. This is not so much for tax receipts as discounts on sales tax.
- 13. I attended a very interesting work shop on anonymity in the Digital Age. I will be recommending to the Mid Winter Round up a workshop on this subject and the issue of Anonymity generally. It was a little scary, anything with Google in the Background is subject to data mining. This includes words and phrases and facial recognition. The algorithms know the meaning of "Friends of Bill W" and if you post a picture make sure there is nobody in the back ground who might be recognized. You may suddenly get ads for Hazelton or the Betty Ford Foundation etc.
- 14. GSO and the Grapevine are in the process of implementing new computer systems. This is to make like better and more efficient but also has growing pains.
- 15. GSO and Grapevine have under study more use of the computer web particularly aimed at millennials who have lived with computers and computer apps. Under discussion are video of pamphlets which can be downloaded on a telephone app.
- 16. This is only a flavour of what was learned. Nobody could give me the miracle formula for recruiting volunteers they wanted to know what we were doing. With meeting lists a number of the groups went through the controversy of listing or not listing atheist and agnostic groups. The resolution was similar to our experience.
- 17. As a service nerd, I was in a room full of people with the primary purpose planted in their hearts but focused on the nuts and bolts of how that is brought about in practice.
- 18. It was exhausting but after three days in Las Vegas, I'm with my own people.

Comment from Literature chair: We have had trouble with the new computer system at GSO (as referenced in CS chair's report) as it affects literature and particularly Canadian customers. Because of this I have been using my personal credit card recently and paying myself back from the account.

Question: There is no budget for literature within Central Service, and you have been taking trips to round ups and events - is some of that money coming from central service? Why wouldn't all of the travel expenses come from literature profits? **Answer:** Currently the literature co-chair and I pay for our own meals and gas and then accommodation expenses come from central service. We are currently in an assessment stage with the literature profits, trying to determine exactly what the true profit is because prices change depending on number of items we order at a time. I have been trying to make sure never to order less than twenty items at a time to reduce costs as much a possible, which is making a difference. We are making more profit than originally thought. As time goes on, we will have a clearer picture about profits and expenses.

Bluenose Bulletin:

This month the bulletin has been especially challenging as the necessary information for upcoming committee meetings and service schedules are not submitted by the deadline or not at all. In some cases it has taken several emails/texts/phone calls to get the necessary information to ensure these important items are included in the bulletin. Question: Have you ever considered having a workshop put on to educate members about chairing meetings in the addictive/ mental health areas? Sometimes it seems there is a stigma at play which discourages members from volunteering. Answer: This would be a matter to be taken to District 1 & 2 meetings as it is their responsibility to host workshops.

Question: Have you thought any more about current volunteer format of teams vs groups coming in to put on meetings? Answer: Chair is currently working with forensics unit to discuss this, look into back ground checks and requirements - she is plugging for the idea of groups coming in.

Question: How many people put on a meeting at forensics? **Answer:** We try to have teams of 4, but as few as two would work. 5 or 6 members would be great as well.

Webmaster/Website:

This month's updates to aahalifax.org include the usual newsletter and meeting list uploads, along with uploads of the Halloween Dance and Mid-Winter Roundup flyers. We also began the process of revamping the online meeting list to become compatible with the Meeting Guide App, released by Alcoholics Anonymous World Services, Inc. This app is compatible with Apple and Android devices and will help members search for nearby meetings by location. (there are only 260 cities who have joined so far so we are ahead of the game) The app also features Daily Reflections and links to other AA resources. There will be no changes to how the print and electronic copies of the meeting list are accessed on the site. The electronic version of the list, however, will see improved search features and be part of a larger and growing AA meeting database. Even better, both our site and the database can be updated at the same time.

Mailbox for Central Service:

Comment: Mailbox originally used for donations and important bank statements but this is no longer relevant. Most of the mail is junk mail or the odd communication from GSO. Our current mailbox contract runs out March 31. Another option is to use a personal home address for which there would be no fee, but the address would be changing every two years. We will discuss this further when we approve the 2020 budget.

Christmas Social Dec 24:

It has been three years since the party was hosted at Club 24 so the Eye Opener group would be willing to host this year. Sackville groups discussed the topic and were hoping someone from Halifax might step up. Halifax groups operate mostly in churches where they have events on Christmas Eve, so it is difficult to host there. Should this be brought back to the Eye Opener group to be discussed? - It has already been discussed.

Motion by Emily S that the Eye Opener Group host the Christmas Eve social at Club 24 this year. Seconded by Kelly D. All in favour. Motion passed.

NEW BUSINESS:

Insurance increase:

Is the executive committee allowed to make decisions like this (as mentioned in the chair's report) to absorb the cost of the insurance increase (appox \$120) without bringing it to the table and back to the groups?

- This increase was mentioned as a possibility in a clause in the contract which was approved by this table if there are groups added, the insurance company reserves the right to readjust the fee. The increase, an additional bill, was sent to us after this table voted on the original cost and contract. It has to be paid no matter what. The only alternative is to go to each group individually and ask them for an additional payment of \$3 and change.
- Central service representatives were not asked about this.
- But we did report the action to the table.
- It seems this is a common sense decision, it is the business of the executive committee to take care of this issue if the table voted that Central Service would not absorb the cost, what would happen then?
- We feel it is the right thing to do to ask for the approval of the table for this action because it is the right thing to do.

Cathy M made a motion to approve the action of the central service executive committee to absorb the additional cost of approximately \$120 insurance increase by Central Service. Seconded by Troy S.

25 in favour, 2 abstentions. Motion passed.
