District 1 DCM Report to Districts 1 & 2 Central Service Committee

Submitted July 6th, 2020

2020 Nova Scotia Service Weekend

- Took place over the four days of June 6th, 12th, 13th, and 20th using the Zoom videoconferencing platform.
- The June 6th evening meeting consisted of receiving reports from the two archivists, as well as an Area 82
 Committee meeting with participation by the Area 82 officers and many of the seventeen DCMs from throughout Nova Scotia, Newfoundland, and Labrador.
- A workshop entitled *Many Aspects of Service*, was held on June 12th for A.A. participants throughout Area 82, and beyond. This well-received and inspiring workshop was expertly facilitated by Billy N. of Buford, Georgia. At one point I noted there were 99 participants in the videoconference.
- The main business of the Nova Scotia Service weekend took place on Saturday, June 13th, with a total of 14 of the 27 G.S.O.-listed groups in District 1 participating (a 52% turnout compared to the 38.5% turnout for the in-person weekend held in Truro in 2019). Overall, of the 141 G.S.O.-listed groups in Nova Scotia, 54 participated in the Service Weekend (a 38% turnout).
 - Kirk S., the Area 82 Delegate, gave a report on the 70th Annual General Service Conference which was held using online meeting technology. Kirk's written report can be viewed and downloaded by visiting https://tinyurl.com/Delegate-Report.
- On Saturday, June 20th, an Area 82 service committees' workshop took place which focused on the pamphlet *Speaking at Non-A.A. Meetings* (this pamphlet can be viewed and downloaded by visiting:

https://www.aa.org/assets/en_US/p-40_speaknonAAmeet.pdf). The workshop facilitators were from Tacoma, Washington state.

Polls were taken during the Nova Scotia Service Weekend, and during the Newfoundland & Labrador Service Weekend, with each in favour of cancelling the in-person Area 82 Assembly scheduled for October 9th to 11th, in St. John's, Newfoundland & Labrador. Therefore, the Area 82 Assembly in October 2020 will be held using the Zoom videoconferencing platform.

June 2020 District 1 General Service Committee Meeting

- Held by Zoom videoconferencing on Sunday, June 28th, a total of thirteen people participated: including eleven GSRs; two District 1 officers; the Central Service Co-Chairperson; the Area 82 Alternate Delegate; and the Panel 67 Area 82 Past-Delegate. It is worth noting that 65% of the current District 1 GSRs participated in this meeting.
- Al P. resigned as District 1 Secretary in June 2020. Al has been replaced by Paul B. I thank Paul B. for stepping up to serve District 1 in this position.
- District 1 is still seeking a Treasurer. Anyone interested in receiving information about this position, please give me a call at 902-405-5488.

HOSTING CERAASA IN AREA 82 IN 2023

- O At my request, Tim M., the Panel 67 Area 82 Past-Delegate, spoke on an idea that District 1 has been discussing over the past few months about hosting CERAASA in Nova Scotia from February 24th to 26th, 2023. CERAASA means Canadian Eastern Regional Alcoholics Anonymous Service Assembly and it is held every other year somewhere in Eastern Canada (i.e., Ontario, Quebec, or Atlantic Canada). The next CERAASA is scheduled to take place in St. Catharines, Ontario, from February 26th to 28th, 2021 (for information, visit https://www.ceraasa.org/).
- Because hosting CERAASA would be an Area 82 function, Tim suggested that any motion going forward ought to state that Area 82, not just Nova Scotia, would host CERAASA in 2023. Tim also noted that the other nine areas in Eastern Canada are assuming that Area 82 will be submitting a bid in February 2021 to host CERAASA in 2023.
- Tim described how helpful his participation in the February 2017 CERAASA held in Moncton was to him as a then new Area 82 Delegate. He was able to meet the nine other Eastern Canada delegates before participating in his first General Service Conference held later in April 2017.
- Additionally, Tim outlined how important hosting a CERAASA would be to raising the profile of general service in Area 82, and for helping members in Area 82 to gain a better understanding of the nature and role of general service in Alcoholics Anonymous.
- o Finally, Tim noted that District 1's idea of holding CERAASA in 2023 in conjunction with the Mid-Winter Roundup in 2023 could be a possibility, particularly if the registration monies were kept separate for accounting purposes. He also stated that organizing committee volunteers could be solicited from across the two provinces in Area 82, as well as from the rest of Eastern Canada.
- The A.A. groups in District 1 are now considering whether to move forward with a bid or motion to Area 82 to host CERASSA in District 1 in 2023, and, while no decision has yet been made, discussions will continue.

The next District 1 workshop will be held by Zoom videoconferencing on Sunday, July 26th, from 1 pm to 2 pm. The workshop is entitled *Contributions and Self-Support: Understanding the Seventh Tradition*, and will be facilitated by Mary W. of the Back to Basics Group. District 2 DCM Report July 7, 2020

Good evening friends, I am grateful to be here and grateful to be sober. District 2 held their June monthly meeting through Zoom with three GSR's in attendance plus the executive of District 2.

The month of June was busy with Area 82 and District 2 business, even with the restrictions on social gatherings:

- The 2020 International Convention Virtual site is now accessible on <u>aa.org</u> and the site will be available all throughout the month of July 2020. The direct link is https://2020convention.aa.org.
- The Area 82 Officers and DCMs from Nova Scotia and Newfoundland met on June 6 via Zoom.
- Area 82 held a workshop via Zoom on June 12 covering the "Many Aspects of Service". Billy N. (Class B Trustee, Past Director and GSD) did a great job talking about his many roles in service and gave great insight on Service in AA as a whole.
- The virtual NS Service Meeting was held June 13. There was representation from 54 groups (38%) and all 11 districts in Nova Scotia. District 2 had 6 of its 16 groups represented. Below is a list of the highlisghts:
 - An update on the money contributed to the Eastern Canadian Hospitality Suite at the 2020 International Convention was given by Tim M. Past Delegate
 - o No report was given for AACYPAA or Remote Communities
 - o The Archive Committee has received a few submissions for the time capsule but are still encouraging members to make a contribution
 - o The Area website has been busy with members looking for information on virtual meetings
 - o CERASSA 2021 is planning to be held on February 26-28 at the Holiday Inn in St. Catherine's Ontario
 - o Monique M. Area 82 Treasurer lead a great discussion around the 2020 and 2019 financial statements
 - o Trudy A. Alt. Delegate gave a report on her work with PI, CPC, Corrections, and Treatment Committees in Area 82 over the last few months.
 - Kirk the Area 82 Delegate gave a lengthy and in-depth report on the 70th General Service Conference that was held virtually
 - o The four proposals from the groups were discussed in much detail with great participation from the DCMs and GSRs. These will be voted on at what looks like a Virtual Assembly in October
- Area 82 held a virtual workshop on June 20 on the pamphlet "Speaking at Non AA Meetings" in place of the Saturday Night Sharing Session portion of the Service Weekends.
- Area 82 is currently reviewing the financial situation for 2019 and 2020 to determine how much of a donation can be sent to GSO.
- The plan is to put an audio recording of the two Area 82 workshops on www.area82aa.org along with a copy of the Delegates Report from the General Service Conference.
- Area 82 and District 2 is recommending groups do not make contributions to them at this time. GSO has made a \$3 million drawdown from the Reserve Fund, so any contributions would be appreciated.
- The Alt. Delegate for Area 82 is holding monthly Zoom Meetings to discuss any challenges or successes Committees (PI, CPC, Corrections, Treatment, etc.) are facing.
- District 2 will be having their regular monthly meeting July 19 at 2pm. I will make the decision on if it will be in person by the end of this week.
- District 2 will not be holding a workshop in August due to the restrictions on social gatherings, lack of participation at previous workshops, and the vacant Alt. DCM position.
- The following groups in District 2 will be resuming in person meetings

- o Colby Village Big Book Study effective June 6
- o Circle of Sisters on Saturdays effective July 11
- o Porters Lake effective July 7
- o Keep It Simple effective June 29

Do we need something written for the process to go back to face to face meeting? Local Heath rules must be followed with proper precautions

Carol Ann – Back to Basics is voting on returning to regular meeting. Looking for input from groups that have already reopened. Micheal suggested talking to Cathy after the meeting.

Jamie – great to put something together but it would only be suggestions. Our four groups meet out of the same room and the center is looking at letting us reopen on Aug 4. To do so we would have to follow any and all health rules as well as the rules the center has put in place.

Cathy – We are noticing that it is one thing to social distance etc when everyone is sitting but as soon as anyone starts to move around etc they are no longer 6 feet apart.

Angus – It is important to note that the rules we have to follow are the minimum acceptable as well.

Murdo – Some groups are asking for waivers to be signed starting groups and or the buildings the meeting is held in are not responsible.

Cathy – stating they have a sheet that has to be signed but it is more for contact tracing.

Memo Open Meetings and Covid 19 1. This document is prepared for information purposes to assist the deliberations of A.A. Groups considering opening up and providing in-person meetings. 2. By virtue of the Health Protection Act of Nova Scotia, the government has made certain regulations which must be obeyed for holding in person events. 3. An A.A. group or body is not above the law. 4. Failure to abide by these regulations, carry penalties. 5. These are known as "strict liability" offenses. It means not following the regulation makes you guilty; the lack of bad intentions does not get you off. 6. Under the regulations as of July 3, 2020, an event is limited to 50% of the set capacity for the room to a maximum of 200. The limit is originally set by the Fire Marshall for public spaces. An outdoor event can have up to 250 people. It is up to the people who run the event to enforce the limits. 7. Under the regulations as of July 3. 2020, there must be social distancing of two metres or six feet between the participants at the event. It is up to the persons who run the event to enforce the distancing. 8. The owners of the facility where the event is held may have additional requirements before any event may be held. 9. The limits on people and social distancing are the only two requirements of the regulations. 10. Anyone may be

sued by simply filing the proper papers to the Court. This does not mean that they will win. There are no cases that have been decided so there is no settled legal opinion on Covid for hosts of public meetings. As protection against being sued it is advisable for everyone to practice "due diligence" which is taking all reasonable precautions to protect the general public. This would require following the two regulations strictly; in addition, as suggestions, sanitizing seats and things people might touch before and after the meeting; perhaps no refreshments, no book or pamphlet browsing, requiring masks or making them available; etc. It is about taking 'reasonable' precautions as regular lay people. It is not required to meet the standards of a hospital or nursing home. 11.It is a reasonable suggestion that before the formalities of the meeting begin; that, someone announces the precautions the group has taken in light of the Covid-19 pandemic to protect the public, but that everyone who is in attendance is doing so at their own risk.
