11. Unfinished Business

a. Feedback from District 1 groups on hosting CERAASA 2023 in Nova Scotia from February 24th to 26th, 2023. [A total of \$2,500 in seed money will likely be available (repayable). <u>CERAASA 2021</u> is scheduled to be held in St. Catharines, Ontario, from February 26th to 28th, 2021.]

Tim M was asked to give some suggestions and experience with CERAASA.

- He has heard that volunteers are some time an issue but feels if the event is held with the MWR it would generate a lot of volunteers and enthusiasm
- There is a rotation IE Que. Ont then down to the Area 81 and 82
- CERAASA helps to bring GSO down to the different Areas and shows our membership the other side of service.
- Trudy caution the district that since this is an Area 82 event, other districts in our Area can also host CERAASA
- Question was raised about MWR conflicting with CERAASA Tim Commented we have the resources to host 2 events at the same time as long we keep things separate like registration.
- Steve suggested that this be brought back to our group and revisited at our meeting
- He is recommending that the motion be tweaked to say that the event is an Area82 event not a provincial Event and be hosted by Area 82.
- b. **District 1 Treasurer position opening.** DCM Steve A. called three times for nominations to fill the vacant District 1 Treasurer position. No nominations were received. Lisa N. will continue as Acting Treasurer.

Steve asked was there any questions and there was none. Steve suggested we take this back to our groups.
- 1- Two motions approved by the Acceptance Group on June 20, 2020, for consideration by the

District 1 General Service Committee:

Acceptance Group Passed Motion #1: As stipulated by a motion passed at the 2017 Area 82 Assembly, and if the calculations deem a contribution for 2019 is necessary, the Acceptance Group maintains that the required Area 82 contribution to GSO for fiscal year 2019 ought to be made on or before October 31, 2020, by any officer of the Area 82 Executive Committee.

Background information: Dwayne M.'s approved 2017 Area 82 Assembly motion (see New Business Item #1, above, for details).

2-Acceptance Group Passed Motion #2: The Acceptance Group asserts that once the required Area 82 contribution has been made to GSO for fiscal year 2019 as per Motion #1

(immediately above), the "excess funds guideline proposal" motion passed at the Area 82

Assembly in October 2017 is rescinded.

- Lisa M explained the current process to the GSR's and feel she is not comfortable with the current process.
- Lisa N, mentioned she voted against the motion and believe the timing is not great
- Paul asked Trudy to commented
- Trudy reported that the reason the payment was not made was because people forget about the motion. Nobody mentioned it in the years after and nobody is the blame. Trudy apologies on behalf of the Area. Trudy explains that the reason district 10 brought their up their new motion was because of the timing of the previous motion. There were several emails sent to Area on this motion and nobody had a exact formula for sending out the payment. Trudy recommended that we bring this back to our groups for review.
