CERAASA 2021 is scheduled to be held in St. Catharines, Ontario, from February 26th to 28th, 2021.]. Trudy reports that If we cancel Cerressa we owe the Hotel 45000 and if they cancel, we owe nothing. This is because we still can be under the Covid 19 Restrictions. Lots of discussion took place and it was decided that we take this back to our groups for another discussion. More information is needed from the Groups to move forward.
- b. Two motions approved by the Acceptance Group on June 20, 2020, for consideration by the District 1 General Service Committee
 - 1- Acceptance Group Passed Motion #1: As stipulated by a motion passed at the 2017 Area82 Assembly, and if the calculations deem a contribution for 2019 is necessary, the Acceptance Group maintains that the required Area 82 contribution to GSO for fiscal year 2019 ought to be made on or before October 31, 2020, by any officer of the Area 82Executive Committee. Background information: Dwayne M.'s approved 2017 Area 82 Assembly motion (see New Business Item #1, above, for details). There was a lot of discussion and confusion and questions on this motion. It was determined that it was missed Emily GSR for the acceptance group agrees to rescind the first motion for it has been resolved
- 2 -Acceptance Group Passed Motion #2: The Acceptance Group asserts that once the required Area 82 contribution has been made to GSO for fiscal year 2019 as per Motion #1(immediately above), the "excess funds guideline proposal" motion passed at the Area 82

Assembly in October 2017 is rescinded. Brian ask for more clarity on this motion. After a lot of discussion and comments, **Leah suggested that this be brought back to our next meeting as a Single motion where we can discuss this in more detail**. All Agreed
