GSO and Area Contributions- was agreed \$1000 for both.

Motion made by Michelle to accept the Proposed Budget 2023, 2nded by Jonathan, motion passed.

Motion made by Samaira to transfer \$1,340 to Prudent Reserve, 2<sup>nd</sup>'ed by Paul, motion passed.

Further discussion on the Proposed Budget 2023 will take place in the next district meeting in March 2023.

**Invite to Area Officer**- Paul inquired if there was an invitation sent out to Area to come to our district meetings. Jonathan informed the meeting that Area was invited to all the District meetings.

## Appendix B – DCM January 2023 Report

#### **District 1 DCM Report**

- **Area 82** 1. An informal cost evaluation was carried out for the Area 82 Fall Assembly attendance in Corner Brook Newfoundland in October 2023. All Area 82 GSR's and DCM's are invited to attend. This Assembly, to fly or sail, is around \$1400 for transport, lodging, and food. When you attend, you have a voice and a vote representing your group.
- 2. District 1 DCM asked if a Hybrid Area 82 Fall Assembly would be feasible. The GSD was to look into this for those groups that are too small to pay for someone to go. But many expressed how we lose fellowship if we keep things digital.
- 3. For a formal cost analysis, there was a motion put on the table, Area 82 (Secretary and Chair) will send out a request to all Districts requesting interested members forming an Ad Hoc Committee to study the most economical way to get people to NL for the Fall Assembly.
- 4.. On the 14th February, there was an Area 82 Area Officers and DCM meeting to vote/accept the CERAASA rotation that, "Area 82 shall host the 2025 CERAASA (Canadian Eastern Regional Alcoholics Anonymous Service Assembly). The vote was unanimous, that we Area 82 shall host the next CERAASA. There will be a bidding process from within Area 82, more to follow on timelines/requirements etc.
- **District 1 -**1. Gilles from Central Service (Treatment Chair ) has requested the Groups to connect with him to be placed on the rotation. Forensics is back to having meetings inside the hospital facility. Gilles is asking all General Service Reps (GSR) to take back
- to their groups and ask if they wish to be involved in carrying AA's message to the suffering alcoholic in Treatment. The GSR is being informed due to some groups not having a Central Service Rep. (yet) Gilles Treatment email: Treatment.AAHalifax@gmail.com phone # 902-403-7305.
- 2. Executives of District 1 met with Executives of District 2 15th February, 2023, to bridge the gap in knowledge of service. Topics discussed were how to create more participation/interest within the Districts. Are AA groups supporting local, district, area and G.S.O services in terms of providing contributions,

attending or taking service commitments? If not, why not? Are there ways of building greater support? It was decided that we would meet monthly to learn from each other's trials and successes.
