- Mary W put a motion on the floor to approve the revenue of the Group Contributions at \$4680 dollars for the 2023 Proposed Budget. Samariah seconded. Motion passed.

Elections for Alt DCM/ Alt Treasurer- No nominations.

Grapevine Display- Discussion was had to come to a decision on whether we should search for the display by going back thru the minutes, asking people in groups on if they have seen it. Was also discussed if we could purchase a new one.

Michelle W mentioned that a wide search was completed including a notice on the website and newsletter.

Samariah mentioned that even if the old one is found that it is likely out dated so purchasing a new one may be the right way to go.

Mary W noted that the last kit was actually made from a member.

Samaria stepped up and will make up a Grapevine Display Kit.

Motion by Michael H that Samaria to make up a Grapevine Display Kit so she can show it to the group at the next District Meeting, 2nd'd by Samaria, motion passed.

12. New Business:

Area 82 Officers Meeting (end of April)- District would like to bring up to the Area reps about the Participation Survey going forward.

Disbursement of Funds- Central Service Treasurer has told District that they do not need money and Mary W is still waiting for a response from the Area Treasurer. Mary W then asked if we should send money to GSO.

After a discussion it was agreed as we approved the 2023 Budget that \$1000 be sent to GSO.

Unity and Participation: Mary W proposed bringing back 4 committees (Treatment, Corrections, CPC and PI) from GSO and back to the District Level to help encourage more participation.

District 2 is also interested and both Districts have thought that splitting the 4 committees in two.

Samaira outlined the 4 committees to the group for the benefit of the new GSR's and explained that they fall under Central Service .

It was brought up by Michael H that in the service manual that those committees actually do fall under the District level.

It was brought up that the GSR's would have to report to their groups to discuss and the CSR's for the group would need to bring this up at the Central Service Level. Also we would need to discuss with District 2.

GSR's to take this back to their groups to discuss: There is a movement to have 4 committees (Treatment/ Corrections/ CPC/PI) under Central Service back to District 1 and 2 so that it aligns with AA and the Service Manual.

GSR's also to ask their groups if they agree that District One and Two should split the committees in half.

Zoom or in person District Meetings- was all ready voted on that District One meeting on zoom for this year.

Workshops: Samaria mentioned that Area 82 on their website has a great template on Workshops and that workshops should be less speaker meeting, and follow the GSO specifications of what a workshop is. Guide lines should be followed during workshops.

Was suggested that perhaps GSO could come for a work shop on Conferences in general. DCM to action.
