- Agenda items for spring assembly can be submitted at any time.
- May 2022 PE regional forum: Members of GSO put on the forum for groups, excellent info provided.

10. Unfinished Business:

-Nomination for Alt DCM: DCM Paul

A call for nominations was made. No nominations were put forward.

New Business:

-Feedback/questions on the Area Assembly (transferred from October – Old Business):

At the October meeting, there was a general discussion on the recent Fall Assembly from those who attended, there were some questions for the Area Officers. The Area Officers attended the November District meeting and answered the questions from the District 1 GSR's, by round table, as follows:

Questions arising for the Area Officers regarding the Area Assembly:

- 1. The 2021 travel expense and 2022 travel budget seem high, any comment from the Officers on this and the potential for keeping the Area business on Zoom?
 - Much of 2021 was on Zoom, travel was minimal. As to continuing on Zoom, the group conscience of the Area was to hold the spring Assembly on Zoom and the fall Assembly in person. Group attendance has been an issue when travel is required to Assembly's, however, even on Zoom, the Area Assembly struggled with low attendance.
- 2. The agenda info and request for agenda items that was received by GSR's in advance of the Area Assembly was not provided in sufficient time to allow for GSR's to gain feedback from their groups and return to District/Area for inclusion in the Area Assembly.
 - The Area Delegate apologized for the short notice given for agenda items, they are new in their roles and learning. They will attempt to be more on top of reminders related to agenda items and encouraged groups to forward their Area Assembly agenda items at any time to their District/Area. There is no need to wait for a call or reminder for agenda items.
- 3. There was some feedback that some GSR's felt unheard/not part of the Assembly.

 Concern was noted and the Area Delegate spoke to her wish that all GSR's feel included in the Assembly. She was required to sub in for the Chair at the Assembly and that could have contributed to the problem as it was her first time chairing this event.
- 4. Regarding the Assembly agenda, item 8. This item was removed, why was this done and what was done with it?
 - The item was around purchasing a laptop for the Area Secretary. The Secretary's laptop stopped working and she was loaned one by the Delegate. Given the pressure to the Area budget, this was removed as it was a "nice to have" rather than a requirement, for the time being. At the DCM Area Officer's meeting in advance of the Assembly, this item came up and the DCM's voted to remove the item from the agenda based on the above.
- 5. There were a few items added to the final agenda in the days leading up to the Assembly, how does this occur?
 - Area DCM's have a meeting in the days leading up to the Assembly. If there are any items the DCM's feel need to be added or removed from the final agenda, they request and vote on this at the Area Officers meeting in advance of the Assembly.
- 6. The Area Guidelines state the bank statements will be attached to the quarterly financial reports by the Treasurer. This has not occurred, and a group will be making a recommendation that bank statements be included in the quarterly financials.
 - The Area Delegate commented that the bank statements haven't gone out with the Area Financial reports in the past, however, if the Guidelines say they should be there, they will look at that and ensure they are in line with the Area Guidelines.
- 7. General Service Conference report, where can we find that?
 - The DCM has a copy of that for sending to GSR's and it is also on the Area 82 website.

There was positive feedback on the speakers at the Assembly. Also, appreciation was expressed to the Area Officers in attendance at the District meeting for the responses to District 1's outstanding questions.
