I attended the Central Service meeting, DCM Meeting for Area 82, and NS Service Meeting and Workshop during the last month. Area 82 held a workshop on June 12 covering the "Many Aspects of Service". Billy N. (Class B Trustee, Past Director and GSD) did a great job talking about his many roles in service and gave great insight on Service in AA as a whole.

I enjoyed attending the Central Service meeting and heard how District 1 & 2 are involved with carrying the message to current and potential members of AA. All the committees are doing a great job at serving Districts 1 & 2 during the COVID-19 pandemic. PI and CPC put on a zoom presentation for students of the Maritime Business College. All meetings at Detox and Corrections are cancelled and currently Zoom meetings are not being offered. The Literature store reopened on June 6 and will be open every Saturday from 11am-1pm. PI was involved in a presentation for the East Coast Music Industry. The Technology Committee is currently working on a number of tasks and have released their recommendation on collecting the 7th

Tradition Electronically. Hospital Visitation had volunteers available to make phone calls to individuals who did not have internet access. The Telephones were being shared between a few members, but the decision was made to return the weekend phones to the groups. The Mid-Winter Roundup held a meeting on June 7 for elections and are looking at options for holding the roundup virtually, if required.

The NS Service Meeting had representation from 54 groups (38%) and all 11 districts in Nova Scotia. District 2 had 6 of our 16 groups represented. An update on the Eastern Canadian Hospitality Suite at the 2020 International Convention was given by Tim M. Past Delegate. No report was given for AACYPAA or Remote Communities. The Archive Committee has received a few submissions for the time capsule but are still encouraging members to contribute. The Area website has been busy with members looking for information on virtual meetings. CERASSA 2021 is planning to be held on February 26-28 at the Holiday Inn in St. Catherine's Ontario. Monique M. Area 82 Treasurer lead a great discussion around the 2020 and 2019 financial statements. Trudy A. Alt. Delegate gave a report on her work with PI, CPC, Corrections, and Treatment Committees in Area 82 over the last few months.

Kirk the Area 82 Delegate gave a lengthy and in-depth report on the 70th General Service Conference that was held virtually. He sent his report to all the DCM's of Area 82 and I have distributed it to the groups in District 2. The four proposals from the groups were discussed in much detail with great participation from the DCMs and GSRs. This will be voted on at what looks like a Virtual Assembly in October.
