DCM Report

The last month was quite with District, Area, and Central Service-related business. Central Service did not hold a meeting in January as the Chair had issues with Zoom. No further positions were filled at Central Service, so the positions of Co-Chair, Treasurer, and Secretary remain open for the 2022/2024 term. Several one-year positions also still remain vacant for Chair and Co-Chair of some of the sub-committees.

The Area Chair communicated the new restrictions at meetings are as follows: up to 25% of legal capacity (overall maximum of 50 persons), all persons in attendance must adhere to physical distancing, and wear masks at all times.

The new aa.org website was launched in December which will prove to be a very effective tool in carrying the message of Alcoholics Anonymous. AA World Service is currently out of stock of the English hardcover Big Book due to a disruption in the necessary paper delivery during the holidays at their printing plant. They are in communication daily with their printer to

emphasize how important this book is in carrying A.A.'s message to our Fellowship and beyond. The expected in-stock date for copies of the hardcover Big Book, to be available for order from their warehouses is currently mid-February. The highlights from the AA World Service Board Meeting in December were communicated from the General Service Office. Group contributions to GSO and Literature are trending over budget for a total surplus of \$1.9M for the first ten months of 2021. The reserve fund is at \$12.8M, which represents 8.5 months of expenses (target of 9-12). AA Grapevine is offering free shipping on all products in the month of February.
