Principal of Concept is Reliance: Once the groups share its conscience with the Area Delegate, the Conference develops a collective conscience so that effective action can be taken.

The Conference Listens and Then Speaks: Execution responsibility is passed onto the appropriate service entity (General Service Board, A.A. World Services, Inc., and A.A. Grapevine) tasked with implementation. Generally, no action can be taken unless the conference directs it to be done.

DCM Report

The last month was busy with District, Area, and Central Service-related business. I chaired the Central Service meeting as all the executive positions were vacant. I am very pleased to report that all the executive positions were elected as follows: Samaira G. (Chair), Tim M. (Co-Chair), Foster L. (Treasurer), and Emily S. (Secretary). Several one-year positions still remain vacant for Chair and Co-Chair of some of the sub-committees. A total of 17 groups were represented, so thank you to everyone who attended the meeting.

All the committees at Central Service are doing a great job at serving Districts 1 & 2 during the pandemic. Corrections are still not able to host meetings. Hospital Visitations has a communication package ready to distribute to nursing homes and hospitals. Help Email had 16 individuals contacting for various reasons. The Telephones has new weekend rotation completed for 2022. Treatment will be resuming meetings at the Marguerite Center in February, have continued meeting at Detox, and Forensics is still not open for meetings. The Newsletter would like to remind everyone to send any meeting changes to the Newsletter and Webmaster emails. Literature has placed an order for books and were waiting for them to arrive. The Webmaster gave a report on the website traffic. CPC, PI, Entertainment, Bridging the Gap, and Round Up did not report.

The minutes from the Area 82 Fall Assembly have been distrusted. A quarterly Area 82 DCM and Area Officers meeting will be held on March 13 to review the year end financials of 2021 plus a few more agenda items. To end 2021 Area had a combined total of \$35,405 in the bank plus an estimated return of \$9,000 from the Area Officers advances. This will be used to fund the \$30,900 budget for 2022 and the prudent reserve. The Spring Assembly will be held on May 27-29 on Zoom. A Pre. Conference to discuss the GSO Conference agenda items will be held on April 2 on Zoom. District 2 is responsible to summarize 11 agenda items from the Policy and Admissions, Finance, and Grapevine Committees.

The highlights from the AA World Service Board Meeting in December were communicated from the General Service Office. GSO had total surplus of \$1.9M for the first ten months of 2021 and a reserve fund of \$12.8M to end October. A new aa.org website was launched which will prove to be a very effective tool in carrying the message of Alcoholics Anonymous. The Eastern Canadian Forum is still scheduled for May 13-15 in Charlottetown.

I would like to remind all groups of the current restrictions at meetings are as follows: up to 50% of legal capacity, all persons in attendance must adhere to physical distancing, and wear masks at all times.
