INTERPRETATION OF TRADITION 1

Michael

Tradition 1 ~ Our common welfare should come first: personal recovery depends upon AA unity.

The main principle in Tradition 1 is unity. Its the 12 steps way, the spiritual path for recovery for the individuals effort. The 12 traditions provide principles that keep the group healthy and grounded. This is best example of tradition 1. Each member of AA is but a small part of the greater whole. AA must continue to live or most of us will surely die. Hence our common welfare comes first but the individual welfare follows close after. The underlying principle is simple. If the group is drawn into controversy or becomes dominated by individuals, the unity of the group will be jeapordized. This is especially true of members who feel sidelined or minimized. These individuals are most likely to drift away or leave the program altogether.

When people try to first recover from alcoholism they often are kept to do it alone. While some people are unsuccessful this approach means that people are less supported and more likely to feel isolated in their recovery. By building a connection with a group, people are better able to understand the individual cause by still trying to benefit from the cohesiveness of a unified group. They say in AA the groups are the most important parts of AA and that is why we sit here at District level and we come back to carry a message to the group because the individual vote is important. Its not only important for me to be sitting at a home group and be able to provide a voice for my group is vital. At a group level this is everything that comes from within AA

The home group is essential. It makes me accountable for myself and accountable to the group and the group is accountable to me.

2023 BUDGET ~ Blair

Correct Budget. Take \$560 we had for Dec 2022 then add \$13 for Nov 7th tradition and \$50 to pay for group insurance that came out. That is \$523 as income. \$2344+\$523 = \$2867. Those few things were not reflected on Decembers statement.

Our balance is \$2867. \$1603 is in the prudent reserve with a total cash of \$4470.

Total Expenses = \$2805

Total Revenue ~ \$2100 Total Expenses ~ \$2805

Net Income shows loss of \$705. Tell groups we need contributions.

What do we want to do with \$2100 Revenue? GSO, Area.

Do we want to do something as a district. For instance maybe buy a laptop for secretary to use?

Blair ~ I motion that we have \$2100 in Total Revenue and Total Expenses are \$2805 leaving us with a loss of \$705. Joanne seconded it. 2023 Budget.
