DCM Report

April 21, 2024

I attended the Area 82 Fall Assembly meeting in March. There was more talk about the letter requesting Districts 1 and 2 to assist with the luncheon. I received the letter and have forwarded it to this committee. After further discussion with them at the April meeting, the actual amount that they will require is not currently known.

(Some discussion followed concerning the Assembly Committee's request)

I attended the Area 82 Active Committees Meeting. Still not much attendance, but the host had some technical difficulty getting the meeting started so that might have been why.

I was not able to attend the Central Service meeting this month.

I was able to attend the Pre-Conference Assembly meeting on Zoom on April 7. I was the only representative from District 2. There were no GSRs nor any other members from this district which I found disappointing. But, as your representative, I let the delegate know we approve of the requests to create a pamphlet for the unhoused alcoholic as well as a pamphlet for the transgender alcoholic. The general feeling from other districts was the same.

I attended the workshop on April 14. There were 24 in attendance. Gilles and his panel did a good job presenting the message of doing service in treatment.

I was at the Spring Fling dance. Good attendance.

The spring assembly is coming up in May. There will be several items on the agenda submitted by various districts. We will meet once more before that happens. The position of Area Webmaster is available and that person will hopefully be voted in at the spring assembly. I will be attending that event.

As DCM for District 2, I have access to the Fellowship Connection database which,

among other things, has a listing of all groups in District 2 and whether or not their status is active, inactive, or unknown. This includes virtual groups. Their current records show only 12 groups in district 2 as being active and 2 of those are virtual groups. There are 4 groups with an unknown status. Colby Village Big Book Study Group, Porters Lake Group, Circle of Sisters Group, and All Beliefs Count Group. After speaking with member services, they did inform me that nothing can be done about groups that no longer exist, they just leave them in the database with status as inactive. As for the active groups that are listed as unknown, we just need to give GSO Member Services the current info (GSR or Group Contact) and once they have that, they will change the group's status to active. The email address to send the info to is: memberservices@aa.org. After confirming with the group GSRs, I emailed GSO the information for Colby Village Big Book Study Group and for Circle of Sisters Group. I am still waiting to hear back from the 2 other groups. Circle of Sisters Group is now listed as Active.
